Mongolia is a landlocked country located in East and Central Asia bordered by Russia and China. The geography of Mongolia is varied with the Gobi Desert to the south and mountainous regions to the north and west. The government system is a semi-presidential republic; the chief of state is the president, and the head of government is the prime minister.

Mongolia is a member of the Asia-Pacific Trade Agreement (APTA).

Risk Assessment (Provided by Coface)

Country rating: C - A very uncertain political and economic outlook and a business environment with many troublesome weaknesses can have a significant impact on corporate payment behavior. Corporate default probability is high.

Business Climate rating: B - The business environment is mediocre. The availability and the reliability of corporate financial information vary widely. Debt collection can sometimes be difficult. The institutional framework has a few troublesome weaknesses. Intercompany transactions run appreciable risks in the unstable, largely inefficient environments rated B.

Strengths

- Vast mining potential (coal, copper, gold, iron, uranium, rare earths), main source of FDI
- Strategic geographical position between China and Europe/Russia
- Stable democratic institutions

Weaknesses

- Small, landlocked economy that is insufficiently diversified and vulnerable to fluctuations in commodity prices
- Heavy dependence on Chinese demand and Russian energy
- Foreign exchange reserves insufficient to absorb external shocks
- Corruption and weak governance (justice, public spending, state-owned companies, mining licences and public contracts)
- Risks of rising inequality due to non-inclusive mining development
- Massive soil degradation that threatens large areas of pastureland with desertification
