outlook and a business environment with many troublesome weaknesses can have a significant impact on corporate payment behavior. Corporate default probability is high.

Business Climate rating: A4 - The business environment is acceptable. Corporate financial information is sometimes neither readily available nor sufficiently reliable. Debt collection is not always efficient and the institutional framework has shortcomings. Intercompany transactions may thus run into appreciable difficulties in the acceptable but occasionally unstable environments rated A4.

Country rating: C - A very uncertain political and economic

Strengths

- Much lower risk of jihadism than its Sahelian neighbours
- Financial support from bilateral and multilateral partners
- Degree of macroeconomic stability, even in difficult circumstances
- Mineral resources (iron ore, gold, copper, uranium) and fisheries
- · Energy potential (gas, green hydrogen)
- Relatively large domestic budget resources

Weaknesses

- Poor governance: high levels of corruption, lack of insolvency procedures
- Undiversified economy, vulnerable to fluctuations in commodity prices and the weather (recurring drought)
- Less inclusive growth, weak education system, high unemployment rate (10%), high poverty rate (57% of the population lives in multidimensional poverty)
- Very little arable land, over two-thirds of the country's surface area is desert
- Persistent community divisions: discrimination against the Harratin population, or black Moors who make up 40% of the population and are the descendants of slaves from the Beïdanes, the white Moors
