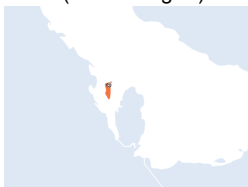


## Introduction

Bahrain is an archipelago of thirty-three islands in the Persian Gulf in the Middle East. It is located off the coast of Saudi Arabia and Qatar. Bahrain has a strategic location in the Persian Gulf, through which much of the Western world's petroleum must transit to reach open ocean. The geography of Bahrain is mostly low desert plains. The government system is a constitutional monarchy; the chief of state is the king, and the head of government is the prime minister. Bahrain is a member of the League of Arab States (Arab League) and the Gulf Cooperation Council (GCC).

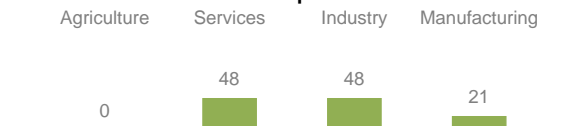

## Risk Assessment (Provided by Coface)

**Country rating: D** - A high-risk political and economic situation and an often very difficult business environment can have a very significant impact on corporate payment behavior. Corporate default probability is very high.

**Business Climate rating: A4** - The business environment is acceptable. Corporate financial information is sometimes neither readily available nor sufficiently reliable. Debt collection is not always efficient and the institutional framework has shortcomings. Intercompany transactions may thus run into appreciable difficulties in the acceptable but occasionally unstable environments rated A4.

### Strengths

- One of the most diversified economies in the region with a higher share of services and manufacturing sectors in GDP
- Presence of a strong aluminum sector, a key contributor to national output
- Low level of inflation and interest rate environment encouraging business operating conditions

### Weaknesses

- Very high external debt-to-GDP ratio (both public and private)
- High budget deficit despite a progressive narrowing from 2021 onwards
- Fiscal revenues still dependent on oil despite a relatively diversified economy
