Risk Assessment (Provided by Coface)

Country rating: B - Political and economic uncertainties and an occasionally difficult business environment can affect corporate payment behavior. Corporate default probability is appreciable.

Business Climate rating: B - The business environment is mediocre. The availability and the reliability of corporate financial information vary widely. Debt collection can sometimes be difficult. The institutional framework has a few troublesome weaknesses. Intercompany transactions run appreciable risks in the unstable, largely inefficient environments rated B.

Strengths

- Well-developed agricultural sector (soybeans and beef)
- Abundant hydroelectric resources and forest potential conducive to green energy production
- · Prudent fiscal and monetary policies

Weaknesses

- Dependency on the agricultural sector and a handful of trading partners (Brazil and Argentina)
- · Vulnerability to climatic conditions
- Significant informal market (40% of GDP), smuggling with Argentina
- Low fiscal resources (17% of GDP)
- · Weak governance (corruption and cronyism)
- · Poor infrastructure (waterways, roads, power lines)
- · Deficient health and education services
