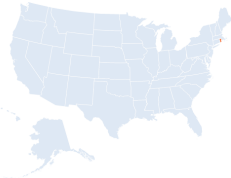


Introduction

Pawtucket, Rhode Island, which is considered the birthplace of the Industrial Revolution. The past few decades have seen a shift in the state's economy from manufacturing to services. Health services and tourism are the two largest industries in Rhode Island, with tourists to the state attracted by beaches, recreational activities, and historical sites. Jobs in finance, insurance, and real estate have all grown steadily in recent years.
